चंद्रमा की सतह के और करीब पहुंचते हुए चंद्रयान-2 को निचली कक्षा में उतारने का दूसरा चरण बुधवार तड़के सफलतापूर्वक पूरा हो गया। इसरों ने एक बयान में इसकी जानकारी दी।

अनाथालय से बच्चों की तस्करी मामले की सुनवाई 17 सितंबर को

लाभ उठा रहे हैं। पूर्व मुख्यमंत्रियों को मिल रही सुविधाओं को लेकर पत्रकार मिलाप चंद डांडिया ने हाईकोर्ट में

याचिका दायर की थी।

इस मामले की सुनवाई मुख्य न्यायाधीश रविंद्र भट्ट के खंडपीठ ने सुनवाई पूरी की थी और फैसला सुरक्षित रख लिया था। हाईकोर्ट ने बुधवार को इस मामले में अपना फैसला सुना दिया। हाईकोर्ट ने अपने फैसले में राजस्थान मंत्री वेतन संशोधन अधिनियम-2017 को अवैध और मनमाना करार दिया। याचिकाकर्ता डांडिया का कहना था कि पूर्व मुख्यमंत्री राजशाही की तरह जी रहे हैं।

इकबाल अंसारी के दावे पर गौर करेगा सुप्रीम

जनसत्ता ब्यूरो नई दिल्ली, 4 सितंबर।

सुप्रीम कोर्ट ने बुधवार को कहा कि वह राम जन्मभूमि-बाबरी मस्जिद भूमि विवाद के मूल वादी मोहम्मद हाशिम के पुत्र इकबाल अंसारी के दावे पर गौर करेगा। अंसारी ने दावा किया था कि हाल ही में अयोध्या में उनपर हमला किया गया है। प्रधान न्यायाधीश रंजन गोगोई की अध्यक्षता वाली पांच सदस्यीय संविधान पीठ के अयोध्या मामले की अपीलों पर सुनवाई के लिए बैठते ही वरिष्ठ वकील राजीव धवन ने इकबाल अंसारी पर हमले ने पुरी को एक दिन की न्यायिक हिरासत में भेज की घटना की ओर उनका ध्यान आकर्षित किया।

एक मुसलिम पक्षकार की ओर से बहस करते हुए राजीव धवन ने कहा, 'बहुत दुख के साथ मुझे आपसे यह कहना है कि इकबाल अंसारी (जो मोहम्मद हाशिम के निधन के बाद मामले को आगे बढ़ा रहे हैं) पर एक शूटर ने हमला किया था। इस मामले में जांच की आवश्यकता है या नहीं, यह मुझे नहीं पता। कभी-कभी अदालत की एक टिप्पणी ही पर्याप्त होती है।' संविधान पीठ के अन्य सदस्यों में न्यायमूर्ति एसए बोबडे, न्यायमूर्ति और ईडी को हिरासत में पूछताछ के लिए याचिका धनंजय वाई चंद्रचूड़, न्यायमूर्ति अशोक भूषण और दायर करने के लिए समय की जरूरत है। न्यायमूर्ति एस अब्दुल नजीर शामिल हैं। प्रधान न्यायाधीश ने कहा, 'हम इस मामले को देखेंगे।'

किया जा चुका है लेकिन इस मामले का तथ्य यह है कि अंसारी को पुलिस संरक्षण प्राप्त है। धवन ने का अनुरोध करते हुए अदालत में आवेदन दिया कहा कि मैं हर एक के खिलाफ अवमानना था। धनशोधन मामला इटली के फिनमेकेनिका की कार्यवाही नहीं चाहता। उन्होंने यह भी कहा कि वे ब्रिटिश सहायक कंपनी अगस्ता वेस्टलैंड से 12 किसी प्रकार की सुरक्षा नहीं चाहते हैं। इस वरिष्ठ वीवीआइपी हेलिकॉप्टरों की खरीद में कथित वकील ने कहा कि वे दिल्ली में ऐसे घर में रहते हैं अनियमितताओं के बाद दर्ज किया गया था। जिसमें ताला नहीं है और कभी भी हमला किया जा हेलिकॉप्टर घोटाले में दिल्ली हाई कोर्ट ने पुरी की सकता है। धवन ने कहा कि आश्चर्य की बात यह है कि अंसारी के पुलिस संरक्षण में होने के बाद भी उन पर हमला किया जा सकता है।

ईडी ने रतुल पुरी को

प्रवर्तन निदेशालय (ईडी) ने अगस्ता वेस्टलैंड हेलिकॉप्टर घोटाले से संबंधित धनशोधन के मामले में मध्य प्रदेश के मुख्यमंत्री कमलनाथ के भांजे रतुल पुरी को बुधवार को गिरफ्तार कर

पुरी कथित बैंक ऋण धोखाधड़ी से संबंधित अन्य धनशोधन मामले में पहले से ही न्यायिक हिरासत में हैं। पुरी को उनके खिलाफ जारी पेशी वारंट पर विशेष न्यायाधीश अरविंद कुमार के समक्ष पेश किया गया था।

ईडी द्वारा गिरफ्तार किए जाने के बाद अदालत दिया और कहा कि वह वीवीआइपी हेलिकॉप्टर घोटाले से संबंधित धनशोधन मामले में हिरासत में पूछताछ करने की जांच एजंसी की याचिका पर गुरुवार को सुनवाई करेगी।

एजंसी ने अदालत को सूचित किया कि हालांकि उसने औपचारिक रूप से आरोपी को गिरफ्तार कर लिया है, लेकिन वह न्यायिक हिरासत के लिए आवेदन दायर करने के लिए विवश है क्योंकि दिन में बहुत देर हो चुकी थी

अदालत ने आदेश में कहा, 'आरोपी को एक दिन के लिए न्यायिक हिरासत में भेजा जाता है। धवन ने कहा कि यद्यपि शूटर को गिरफ्तार आरोपी को पांच सितंबर को पेश किया जाएगा।' इससे पहले पुरी ने मामले में आत्मसमर्पण करने अग्रिम जमानत याचिका को खारिज कर दिया था. और कहा था कि प्रभावी जांच के लिए उनसे हिरासत में पछताछ आवश्यक है।

बस्ते का बोझ कम करने की जयपुर से शुरूआत

जयपुर, ४ सितंबर (भाषा)।

राजस्थान के शिक्षा राज्यमंत्री गोविंद सिंह डोटासरा ने बुधवार को राजकीय विद्यालयों में बच्चों के बस्ते का बोझ कम करने के पायलट प्रोजेक्ट की शुरुआत जयपुर से की।

डोटासरा ने बुधवार को इस संबंध में वाटिका के राजकीय उच्च माध्यमिक विद्यालय में आयोजित राज्य स्तरीय कार्यक्रम में बताया कि पाठ्यपुस्तकों का दो- तिहाई वजन कम किया गया है। अब बच्चों को वर्तमान पुस्तकों के एक तिहाई भार के रूप में अलग- अलग पुस्तकों के स्थान पर एक ही पुस्तक स्कूल लेकर जानी होगी। उन्होंने कहा कि राजस्थान देश का पहला ऐसा राज्य है, जहां बस्ते के बोझ को कम करने के लिए यह पहल की गई है। उन्होंने बताया कि कक्षा एक के विद्यार्थियों की पुरानी

किताबों का वजन 900 ग्राम था, जो अब 400 ग्राम किया गया है। इस प्रकार कक्षा एक से पांच तक की किताबों के वजन को पांच किलो 900 ग्राम से घटाकर दो किलो 200 ग्राम तक कर दिया गया है।

उन्होंने बताया कि प्रायोगिक रूप में राज्य सरकार ने प्रदेश के सभी 33 जिलों से एक-एक विद्यालय का चयन कर बस्ते के बोझ को कम करने की यह शुरुआत की है। इसके तहत कक्षा एक से पांच तक बस्ते का दो- तिहाई बोझ कम हुआ है।

उन्होंने बताया कि बोझ कम करने के इस निर्णय की लगातार समीक्षा की जाएगी। सफल परिणाम रहते हैं, तो आने वाले समय में इसे कक्षा एक से 12 तक प्रदेशभर में लागू किया जाएगा। उन्होंने निजी विद्यालयों से भी अपील की कि वे भी इस तरह की शुरुआत करें।
